Dr. Mildred Huey has agreed to donate some time to meet with Mrs. Danah Telfaire to coach, mentor, and support her. The board will meet again to discuss in depth the academics of the school.

ITEM 3: Action Items Update: Pete Lash moved to accept Denise Watts' proposal, Debra Frazier second, and motion carried. Acadia North Star agreed to reduce our contract from five years to two years. Pete Lash moved to accept Acadia North Star and Power School contract, Debra Frazier second, and motion carried. Spark Strategic Ideas is ready to kick off the school survey. Letters to parents are ready to hand out.
