ITEM 3: Financial Report: Kristin Zettlemoyer reviewed finance report with board. School received CMS payment in July. Revenue is higher by \$110,000. Actual end of FY surplus is \$137,683.81. School audit currently in progress with expected completion in September. Draft of audit report will be received September 8th. PPP Loan forgiveness application is not out yet. School will complete once received.

## ITEM 4: Executive Director Report:

- Enrollment 373
- School received school safety grant to be used later in the school year.
- HVAC not functioning. There is plenty of room to accommodate social distancing.
- School hired new 2<sup>nd</sup> grade teacher ad Brandon Mcelrath will serve as long term sub
- School will participate in a yearlong program fellowship twice per month until July
- School will offer before and after school after fall break and school is currently using Panera Bread for lunches.

- School currently have 100 to 110 champions for in person learning. Families have until October 2<sup>nd</sup> to go from remote to in person learning.
- Possible new grant to assist families with additional childcare
- Funds from Chick Fil A fundraiser will go towards Beta and Art
- Virtual Curriculum is currently being planned

ITEM 5: Board Discussion: Board meetings will be 4<sup>th</sup> Thursdays of each month. No board meeting in November. December 3, 2020 will account for November and December board meeting.
